#### TO OUR CANDIDATES' COACHES

No man in the lodge plays a more important role than you do in the making of Masons. To be sure, the officers must do a proficient and effective job in presenting the ritual - that's axiomatic. But you're the one who really educates him in Masonry and help to shape his attitudes and future Masonic life. Your instruction in the candidates' lecture is fundamental and often demands great skill with certain candidates who do not memorize readily. You are zealous in your efforts to help him to pass a good examinaton. But your task just begins here. The crux of your service is the attitude you create in the candidate as to the nobility, scope and practical applications of Masonry in ennobling life. The candidate needs to know how Masonry came to be; its deep roots in antiquity; the long and honorable line of men who have made it a synonym for integrity; its basic, dual, moral philosophy — the Fatherhood of God, and the brotherhood of man; and its use of symolism to illustrate moral virtues. In short, that in about three hours of Masonic ritual he is receiving much of the distilled wisdom and idealism of centuries. Show him that in every repetition some new gem of inspiration may be discovered that can add stature to his personal life.

You can influence his contribution to the Craft by showing him that regular attendance is necessary and expected. Point out to him every meeting he is eligible to attend during the course of his advancement, phone him and ask him to attend each specific meeting. Sit with him in lodge and see that he gets to meet his brethren by introduucing him.

If you do your job well, the quality of Masonry in Las Palmas Lodge will be greatly enhanced.
