MASTER'S MESSAGE



Brethren:

By the time that you receive this, the Grand Master's Breakfast will have been enjoyed by many of our brethren and the wise and serious truths proclaimed by our Grand Master Chester R. MacPhee will be remembered and being put into practice.

In keeping with the wishes of many brethren, the next Grand Master breakfast will be in the spring, like April 25th, so that we may all meet the new Grand

Master early in his term, that he might speak to us of how we can assist him in reaching the goals he has set for his term of office.

Over 100 of our brethren and ladies were pleased to hear the Constitution Day Observance address prior to our September stated meeting by Municipal Court Judge George Hopper who spoke on "Our Constitution Today." Thank vou Bros. Ken Potter and George Holstein, P.M. for arranging it. He reminded us that our Constitution has stood the "test of time" for 183 years, because Liberty of the constituent people is its basic concept, also that of Faith of our convictions of life having meaning and importance. Judge Hopper assured us that in competition, Truth wins out and the false dies from exposure: that competition in the market place of ideas, brings out the best in all of us; but that in a closed society these are not possible. The right to dissent has limitations, particularly in civil disobedience. He advocated public support and respect for policemen, the basic activators - and contact with the people, to enforce the laws and protect us.

The roast beef dinner before this fine program was excellently prepared under the chairmanship of Margaret Ahlenslager and her good committee of ladies. And her husband, Junior P.M., Bill Ahlenslager, and I announce November 5th as Past Masters' night, the FREE MEMBER-SHIP DINNER, and invite all Las Palmas Master Masons to a big night at the Lodge.

THE SECRETARY'S CORNER



"1970 DUES ARE OVERDUE."

Again I must remind those who have not as yet submitted their dues payment for the year, to do so now. It is very important to you that you do so according to our Masonic Code covering this important matter and to your Lodge. The last thing we would wish to do is to submit a member's name for suspension for non-payment of dues and this is the secretary's responsibility to do so in carrying out the responsibility of his office.

From our total membership there are 63 delinquent members; 50 have not as yet paid their 1970 dues and 13 who have not paid either 1969 or 1970 dues which places them in a very precarious position acording to our by-laws. The total amount of the delinquent dues amounts to \$1510. Your Lodge is dependent upon its dues monies to take care of its operating and maintenance expenses. To those not fulfilling this responsibility, they are derelict in their actions towards their Lodge.

If for some reason beyond your control you are unable to pay; please so advise me by letter so I may be governed acordingly. In not receiving such notice, I shall look forward to your payment without any further delay.

I regret that it is necessary for me to include such a message in this bulletin. Regular delinquent notices have been forwarded to you and I am using this medium to inform the delinquent members in more detail, the importance of this subject to them. Not hearing from you in the near future, either by receiving your check or letter, I must submit the delinquent members names to our dues committee.

We are now entering the last quarter of our year 1970. I hope the year has treated all well. Time goes so fast and we will be knocking at the door of 1971 before we know it. Slow yourself down and "smell the flowers" along the way of life; for the old saying, "it is later than you think" is very true. Enjoy yourselves and visit your Lodge now and then and receive the good fellowship that always prevails here.

The Master's Carpet . . .

As early 18th century lodges commonly met in taverns, inns, or even private houses, lodge furniture was sparse or even absent, so that it was the practice to "draw the lodge" on the floor with chalk or charcoal, showing the various stations, representations of furniture, and symbols necessary to illustrate the lectures. At the close of the lodge, it was the duty of the youngest Entered Apprentice to obliterate traces of the drawings, for which purpose, he was furnished with a "mop and pail," said expression being so common that it became almost a symbol indicative of the Entered Apprentice.

As lodges became better fixed financially, or more meticulous about their work, they had the desired objects and symbols painted on canvas or oil cloth, thus creating floor cloths, floor charts or carpets which could be rolled up and preserved to be used many times. Charts were sometimes suspended on walls or easels. The Master's Carpet related to the Third Degree and among the ideas represented on it were the three stages of Human Life: Youth, Manhood, and Old Age, which were referred to as the Three Steps on the Master's Carpet. Such carpets, floor cloths, and charts are used in many lodges at the present day.

The Character Of A Master Mason

A Master Mason has a public as well as a Masonic character; he must be a citizen before he can be a Freemason. All his reputation as a Master Mason, all the teachings of integrity and fidelity, all the magnificent examples of firmness and fortitude in trial and danger - even in the valley of the shadow - which a man has been taught as a Master Mason are concerned in supporting with dignity his character as a citizen.

When the citizen becomes a Mason he adds to these moral obligations his pledged word, his sacred honor, his character as it is seen naked of God, that he will do certain things and refrain from doing other things. All of these pledges involve not only his duty as a man but as a citizen.

The Master Mason should be a better citizen than the non-Mason because he has been taught and has pledged

his sacred honor.
