# From the Secretary

For the benefit of many of our members and their wives it might be well if we make known some of the rules governing admission to the Masonic Home. Recently a widow of one of our members asked for an application to the home and we had to tell her she wasn't eligible.

The following is quoted from the California Masonic Code, pages 236 and 237: "Applications for admission to this home are made to the lodge in the California jurisdiction in

which membership is held.

To be eligible for admission as a guest, the applicant must be:

(a) A master mason in good standing in a

lodge in this jurisdicition continuously for the past five years; or

(b) The wife of such a master mason; or

(c) The widow of a master mason, who at the time of his death was a member in good standing in a lodge in the California jurisdiction under (a) above.

(The mother of a master mason who is eligible under (a) or who at the time of his death was eligible may be admitted by the Board of Trustees only under extraordinary circumstances, provided, however, that wives and widows take precedence).

Except in unusual circumstances the applicant must be:

(a) In need of financial aid.

(b) Without relatives who are able and willing to support him (or her).

(c) Available for medical examination.

(d) Willing to abide by the rules and regulations governing guests in the Home.

(e) Willing to execute an assignment under which he (or she) turns over to the Masonic Homes of California whatever assets he (or she) may be possessed or may become possessed."

The important words to note in the above set of rules are "good standing for at least five years." Whether a newly-raised member or one who has transferred from another jurisdiction, this rule applies. This prevents a member coming from another jurisdiction to affiliate for the purpose of immediately applying for and receiving admission to the home.

Members should show this article to the wives so that they may be acquainted with the requirements and avoid disappointment in the future should they wish to consider entering the Home. It is indeed a sad duty for the officers of a lodge to inform a widow she is not eligible to enter the California Masonic Home becuase her husband was not a member long enough.

Members transferring from another jurisdiction having death benefits should maintain their membership as dual members of both lodges for at least five years. In this way he will establish eligibility in California while protecting himself and his family in his other jurisdicition.
