We would like to remind our members who are multiple members with other lodges that should they become suspended in one of the lodges for non-payment of dues they will automatically be suspended in the other even though they are paid up in the second lodge. (Art. 2402 #6, CMC)



This rule also applies to members who are members of any organization which requires masonic membership in order to apply for membership. The secretary is required to notify all subordiante bodies when a member is suspended. He cannot be admitted to those bodies until they are notified he is in good standing with his masonic lodge. (Art. 3520, CMA).

### Former DeMolay Members, Attention

We are trying to locate all members of DeMolay who belonged to a chapter in 1932 and before. They are now eligible for a fifty-year pin. ### **Address Changes**

The Grand Secretary is complaining to us. The editor of the California Freemason Magazine is also complaining. They have a good reason to do so. Members are sending address changes to them. This is not the proper way to let them know when you change your address.

In order to notify Grand Lodge about a change is to notify the secretary of your lodge. He will make the change in the lodge records and also notify all other interested persons on special forms for that purpose. There is no other way.

When Grand Lodge or the California Freemason get an address change, they mail your notice back to the lodge, which makes the chnage occur. You can readily see a month or so is involved which delays getting the job done.

When you move or change your address, notify your lodge secretary and he will get the whole job done immediately.

If the above method is not followed, the California Freemason pays 25c to the post office for each address that is wrong. We get the change about a month after the publication is not delivered to you, so we can notify them on their special forms. Probably four months is involved in getting your correct address into the system in this manner.

In case you are wondering why you are not getting your mail regularly, or it gets to you several months late, the answer may be in the method you chose to notify Las Palmas that you have moved.

#### Are Your Dues Paid?

We have been asked by the Grand Secretary to explain to our members some of the laws contained in the California Masonic Code. This book is the final word in procedures for lodges and members thereof in all matters pertaining to membership.

All dues are payable on or before January 1 each year. Some members have not done this. There are probably fifty Las Palmas members now in violation of this section of the Code. Suspension or expulsion could be imposed were it not for the good nature and brotherly love exhibited by the officers and members of the lodge.

We have adopted a policy of taking no action until after a period of twelve months after the violation has occurred. There is no way the lodge can permit a member to be more than a year in arrears without taking some sort of action.

If a member is having financial problems he should let the secretary or Master know of his plight. For just cause a member's dues can be remitted (forgiven), but he must let the lodge know. When we learn that a brother has had a major operation or is confined to a rest home, or otherwise not earning enough money to pay his dues, the lodge learns about it and usually votes to forget about the dues for a year. If next year it will be a burden to pay dues, the member is again issued dues receipt without payment by him.

During the time when much unemployment is prevalent — such as now — a lodge is justified in remitting a member's dues until he is again employed.

If you are having financial difficulties, please let someone know so it can be reported to the lodge and something can be done about it.

Some members are too proud to admit a financial problem. They send us a note asking for a demit and want to withdraw their membership. Nothing like this can happen unless dues are paid up to and including the day in which the request is received by the lodge secretary. Demits cannot be issued to members whose dues are in arrears.

It is not a policy of the lodge to issue demits to members who are in financial difficulties not of their own making.
