



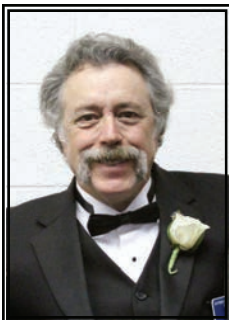

Greetings from the East



As we move into the wonderful autumn season and begin feeling cooler air and seeing changing colors in the foliage, so too will we see changes in the Lodge. As you may know, I recently attended the Grand Lodge Annual Communication in San Francisco. It was the first time I had been able to attend and was most impressed by the array of over 400 Masonic officers from all over the state gathered together in one room. I was very proud that we of Las Palmas-Ponderosa had our full contingent of voting officers present: myself, the senior and junior wardens, and Worshipful Joe Perry representing our past masters. For the most part, I believe we voted in harmony and represented our lodge well. We voted on perhaps several dozen matters affecting the governance of lodges in California. We heard many stout and humorous arguments for and against the issues before each vote. Most dealt with minor, house-keeping changes in ritual, with the majority dealing with closing ambiguities in the CMC regarding finances and record keeping. The one issue that I felt will affect all the brethren the most and immediately I will now focus on.



I was surprised to learn that nearly all other States in the country open their Stated Meetings in the First Degree. This is because Entered Apprentices and Fellow Crafts are allowed to attend. We do ours in the Third Degree and therefore with ONLY Master Masons present. It was decided that as EAs and FCs are members of the lodge they should be present during the conducting of Lodge business. So, henceforth, after the Stated Dinner, EAs and FCs need not go but are welcome to come across the hall and join us! This should result in both having more Lodge members join us for dinner and in having a more informed local Masonic brotherhood. In keeping with this change, EAs and FCs will also participate and support the lodge in joining the Master Masons in the matter of annual dues. Also, although EAs and FCs may attend and add their voice and opinions, actual votes are still to be only by Master Masons. The intention is to encourage EAs and FCs both to come AND to provide an incentive for them to advance so that they may enjoy the benefit and privilege of FULL Masonic involvement. So, I look forward to seeing ALL the brethren of LPP at the next Stated Meeting! I want to thank the brethren of Las Palmas-Ponderosa for both allowing and sending my lady and I to attend this magnificent event in the City by the Bay, and particularly my fellow officers for making me proud!

P.M. Richard Frey's from the Archives



The early part of the 20th century was good to Las Palmas Lodge. During the "teens" we were raising about 15 new Masons each year. In 1916 and 1917 this jumped to 25.

Technology was advancing and Las Palmas was taking advantage of it. After conferring the 3rd degree on Bro R. F. Walker on May 10, 1917, "Lodge was then closed and the members and visitors had the pleasure of witnessing an interesting as well as educational exhibition of motion pictures." At every installation of officers from 1906 until 1917, the retiring master was presented with a gold watch as a token of appreciation from the Lodge. On January 10, 1918, retiring Master Fred L. Swartz was presented with a Victrola.

At the May 1928 Stated Meeting, Bro W. G. Millholland delivered a letter on Radium and Rays. Bro Millholland was a medical doctor and one of the first radiologists in Fresno. At that time the normal procedure was for the doctor to hold the X-Ray film with their hand during the X-Ray. As a result he eventually lost all of his fingers on one hand.

In our November journey into the past, we will talk about the impact of The Great War on Las Palmas Lodge.

RE: Implementation of Resolutions 11-06 and 11-07

Brethren,

At the 163rd Annual Communication of the Grand Lodge of California, the delegates adopted Resolutions 11-06 and 11-07. This memo is intended to provide clarity and instruction in implementing these new ordinances. Please read this memo carefully and see to it that it is distributed to your members as necessary and practical.

Resolution 11-06 changed our ordinances concerning the Stated Meeting. Effective at your next Stated Meeting and going forward, the lodge will be opened in the Entered Apprentice degree and not the Master Mason degree. Entered Apprentice and Fellow Craft Masons now have the right to attend the Stated Meeting. An Entered Apprentice or Fellow Craft Mason may speak during the meeting but he may not ballot on applications nor vote on any other matter coming before the lodge. He should not propose or second motions.

When opening the lodge on the Entered Apprentice degree for the Stated Meeting, remember to state "for the transaction of business" when you announce the purpose for convening the lodge. It should be noted that the Ritual does not allow calling up from one degree to another. It allows calling down for examination in the Candidate's Lecture only. Section 807.010 prohibits lodges from holding a Stated Meeting and a Special Meeting on the same day. Therefore, examination in the Candidate's Lecture of the Fellow Craft and Master Mason degrees is to be done in a Special Meeting of an appropriate degree on a day other than the day of the Stated Meeting. Keep in mind that no Stated or Special Meeting shall be held on Sunday except for the Installation of Officers or funeral services.

Care should be taken when reading the minutes of meetings opened in the Fellow Craft or Master Mason degree to preserve the anticipation of advancement for Entered Apprentice and Fellow Craft Masons in attendance at the Stated Meeting when those minutes are read.

Resolution 11-07 requires Entered Apprentice and Fellow Craft Masons to pay dues to the lodge. It is my decision that this requirement shall be effective October 1, 2012. The lodge should include in the billing for the 2013 dues all Entered Apprentice and Fellow Craft Masons on the rolls. In addition to the 2013 dues amount, the lodge should collect in that same billing a pro-rated portion of the dues for the three months ending December 31, 2012. While the Entered Apprentice or Fellow Craft Mason would not be in good standing until he pays the pro-rated 2012 dues and then the 2013 dues, he only needs good standing status to request a demit and move to another lodge. He does not need to be in good standing to advance or attend the Stated Meeting.

An Entered Apprentice or Fellow Craft Mason may be suspended for non-payment of dues if he has not paid his dues for a period of 12 months. The Secretary shall follow the procedures in Section 809.370 to notify the brother of his pending suspension. The first time an Entered Apprentice or Fellow Craft may be suspended would be after October 1, 2013. If an Entered Apprentice or Fellow Craft has not paid his dues because of sickness or inability to pay, the lodge may remit his dues. No worthy brother who is unable to pay his dues shall be suspended for non-payment of dues. An Entered Apprentice or Fellow Craft Mason may purchase a life membership in accordance with the Code.

Because of the addition of Entered Apprentice and Fellow Craft Masons to the rolls, the lodge will make a per capita contribution for these brothers. As a result of a larger base of Masons, the per capita amount was lowered from the current rate of \$35.00 to \$32.00 for the next fiscal year. If your lodge by-laws have fixed your dues at a certain amount plus per capita, please use \$32.00 when calculating your 2013 dues amount.

The Grand Secretary will issue an update to iMember that will print the member type on the dues card to indicate whether the brother is an Entered Apprentice, Fellow Craft or Master Mason. In the meantime, the lodge Secretary shall print the member type on the lower left corner of the dues cards for all Entered Apprentice and Fellow Craft Masons. It is not necessary to write in the member type of Master Mason, though this will be printed automatically when the new version of iMember is released.

The lodge must issue to the brother a new dues card with the current member type when he advances to the next degree. This is important because an Entered Apprentice or Fellow Craft Mason may visit another lodge working in a degree taken by him, with the consent of the Master of his lodge and the consent of the Master of the lodge visited, if accompanied by a Master Mason who has sat with him in a tiled lodge and vouches for him. The member type printed on the dues card will allow the lodge visited to know the degree or degrees taken by the brother.

As a courtesy to the lodges, the Grand Lodge will communicate directly with all Entered Apprentice and Fellow Craft Masons on the rolls to inform them of these changes. In addition, the lodge should make every effort to reach out to those on their rolls and see to it that Entered Apprentice and Fellow Craft Masons are aware of their opportunity and responsibility for further engagement in the lodge.

QUESTIONS AND ANSWERS CONCERNING 11-06 AND 11-07

Does a lodge have to conduct its Stated Meeting on the Entered Apprentice Degree?

Yes. Effective immediately, all Stated Meetings shall be conducted in a lodge of Entered Apprentice Masons.

Can a lodge call up from the first degree to a higher degree for the purpose of examination or degree conferral?

No. The Ritual does not allow a lodge to call up from one degree to another.

Can a lodge hold a Stated Meeting on the Entered Apprentice Degree and then, after closing that lodge, open a lodge of a higher degree for the purpose of examination or degree conferral?

No. Section 807.010 prohibits a lodge from holding a Stated Meeting and a Special Meeting on the same day.

Can a lodge of Master Masons be called down to a lodge of Entered Apprentice Masons for the transaction of business?

No. A lodge can only be called down for the purpose of examination.

Can Entered Apprentice and Fellow Craft Masons attend the Stated Meeting?

Yes. Effective immediately, Entered Apprentice and Fellow Craft Masons have the right to attend Stated Meetings of the lodge.

Can an Entered Apprentice or Fellow Craft Mason speak on matters before the lodge?

Yes. He may speak on any matter coming before the lodge.

Can an Entered Apprentice or Fellow Craft Mason vote on matters before the lodge?

No. He may not vote on any matter coming before the lodge.

Do Entered Apprentice and Fellow Crafts Masons have to pay dues to the lodge?

Yes. Effective October 1, 2012, all Entered Apprentice and Fellow Craft Masons are required to pay dues to the lodge.

Can an Entered Apprentice or Fellow Craft Mason be suspended for non-payment of dues?

Yes. If he has not paid his dues for a period of 12 months, he may be suspended for non-payment of dues in accordance with Section 809.370 of the Code.

The dictionary definition of Labor of Love – is “productive work performed voluntarily without material reward or compensation.”

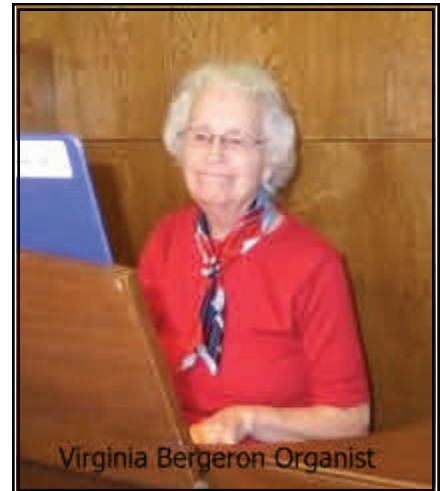
That is exactly what has been transpiring this summer with many of our members.

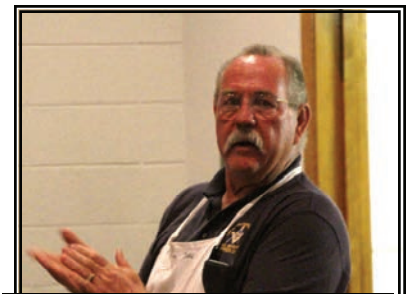

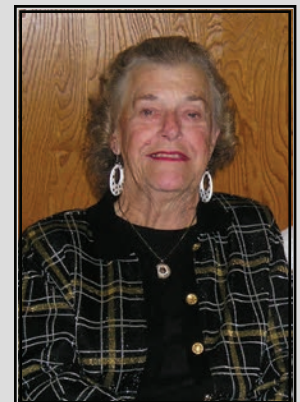
