





There seems to be a trend in California for most lodges to lose members. During and immediately after World War II there was a surge of membership gains, but these members are now advancing in age and for various reasons are dropping out of lodges. It was reported at Grand Lodge last October that more than 3,000 members were stricken from the rolls.

A large number of masons have migrated to the West in the past thirty years, and it may be, with a little persuasion, we can get them to affiliate with one of the Fresno lodges. In this way we can build up our membership without having to confer degrees and coach new members. Many of them are waiting for someone to encourage them to start lodge activity again.

Members of distant lodges are at a dis-

advantage should they require the help of a lodge. Local lodges do not feel a necessity to interfere unless the Brother is one of their members. The home lodge is so far away it is almost impossible to be of any value to the member. The Masonic Service Bureau renders a valuable assistance at these times, but it is not the same as a member's own lodge.

Perhaps we should make an effort to learn of members outside our area and encourage them to affiliate with us. In this way we will be rendering a service to them as well as to ourselves.
