## News from the Office



We have been having trouble keeping up with some of the members of the lodge. They move from one place to another and we sometimes don't hear about it until the California Freemason gets a return copy marked "undeliverable" and the post office gives them a forwarding address.

Then in about a month we get all those little tabs and find out we have been mailing Trestleboards and dues reminders to the wrong address.

It is not much work for a person to call the office some morning and tell us they are moving and give us their new address. Even after they are moved and settled in their new home is not so bad. Often the thrill of living in a new home gets a person's mind off some of the things they should have done.

This year we have two members who cannot get mail to, and have been having trouble for more than twelve months. They have been suspended for non-payment of dues because we cannot reach them with our dues reminders. There is really not much damage done when a member is suspended. Before two years have passed a member may reinstate himself by paying up the dues he has missed, but he does not regain the time lost as an active member when Grand Lodge figures his time towards a fifty-year pin. This is deducted from the number of years and the pin is presented that amount of time later than it should be.

Some members are members of other masonic bodies which require that he be a mason in good standing in his lodge. The Scottish Rite, Shrine and Orders of Eastern Star must also suspend a member who has been suspended by his "blue" lodge.

If we can locate a member we will do everything we can to help him keep his dues current, but Grand Lodge laws do not permit a person to remain in an active status if he fails

or neglects to pay for more than a period of twelve months. We then attempt to contact the member by mail. This takes several months' time, and if this fails to bring results, there is a form we send out notifying the Brother that unless he is paid to current status by a certain time he will be suspended, resulting in a little more time before the lodge can act on the suspension. The thought is — keep us informed of your address!
